Summary and Procedures

Summary

1. The minimum requirement is 90 Points in each 3-year cycle.
2. The minimum annual requirement is 10 Points.
3. Based on requirements of Continuous Professional Development (CPD) by the Academy, all Fellows must fulfill both active and passive components of CME. Each Fellow should attain a minimum of 30 passive Points and a minimum of 30 active Points in each 3-year cycle. For a new Fellow whose first CME/CPD cycle requires fewer than or equal to 35 CME/CPD Points, the Fellow needs only to acquire the required total CME/CPD Points irrespective of the proportions of active versus passive categories.
4. CME Points awarded by Physician Colleges in Australasia, Singapore, United Kingdom and United States are recognised for CME accreditation by the Hong Kong College of Physicians. Formal CME reports from national accreditation bodies should be submitted to the College for the award of CME Points.

Overseas Fellows who are participating in mandatory CME/CPD programmes of local/national accreditation bodies should submit the formal CME/CPD reports from the respective accreditation bodies to the College on an annual basis in order to be recognised as having satisfied the CME/CPD requirements of our College. Requirements pertaining to active versus passive participation do not apply to these Overseas Fellows. Fellows residing or working overseas who are not participating in mandatory CME/CPD programmes of local/national accreditation bodies are subject to the same rules and regulations for CME/CPD as for local Fellows.

5. CME for Physician Trainees

The same CME/CPD requirement of 90 Points in every CME/CPD 3-year cycle also applies to all Trainees. Trainees will be assessed by supervisors and Programme Directors based on information in their log-books.

In addition, a Trainee is required to attend a minimum of 2 meetings chosen from ‘a’, ‘b’ or ‘c’ of the following list each year, and attend ‘c’ at least once every 2 years:

- a. Advances in Medicine, organized by The Chinese University of Hong Kong*
- b. Hong Kong Medical Forum, organized by The University of Hong Kong*
- c. Annual Scientific Meeting of the Hong Kong College of Physicians*

Procedures for CME accreditation of Formal College Approved Activities (FCAA), Overseas Conferences and Certificate Courses

1 Formal College Approved Activities (FCAA) for local meetings/conferences

- 1.1 Application for CME accreditation of local educational activities should be sent to the College Secretariat (address on following page) no later than one month before the meeting. Only prospective application for accreditation will be considered; late or retrospective application will not be entertained. For virtual/online events, the event organizer must submit, at the time of application, information on how genuine reasonable participation by a registrant/participant will be ascertained or corroborated.
- 1.2 Fellows or Trainees who have attended local meetings or conferences with CME accreditation by College and have signed on Attendance Sheets do not need to submit the Certificates of Attendance to the College after the meeting.
- 1.3 Meetings organised solely by industry or pharmaceutical/medical equipment companies with a narrow focus on their commercial products are normally not accredited for CME/CPD.

2 Overseas Meetings

- 2.1 Retrospective application for CME accreditation of attendance at overseas meetings is allowed, provided that the application is submitted to the College no later than 2 months after the end date of the meeting.
- 2.2 Applications must be supported by relevant documents including certificate of attendance, proof of registration, and scientific programme overview, and should be submitted to the Secretariat by mail, fax, or email.

3 Certificate Courses

- 3.1 Application for CME accreditation of Certificate Courses should be submitted to the College Secretariat no later than 1 month before commencement of the course. Only prospective application will be considered. Late or retrospective application will not be entertained.
- 3.2 Award of CME Points for attendance in pre-approved Certificate Courses will be effected upon submission of Certificate of Attendance after completion of the course, and the CME Points will be distributed over the years covered by the course on a pro-rata basis. The Certificate of Attendance should be submitted to the College Secretariat for CME accreditation no later than 2 months after the end date of the course.

- 3.3 For Certificate Courses straddling two or more CME cycles, all CME Points obtained from attendance will be assigned to the cycle in which the Attendance Certificate is received by the College Secretariat.
- 4 After fulfilment of 90 CME Points in one cycle, the CME Board will not award additional CME Points to a Fellow or Trainee in that cycle.
- 5 Every Fellow is required to acquire a minimum of 10 CME/CPD Points per year (i.e. minimum annual CME requirement), from active and/or passive participation in accredited CME activities. It follows that in the first year of the 3-year cycle a Fellow/Trainee can acquire a maximum of 70 CME/CPD Points, and in the first two years a maximum of 80 CME/CPD Points. Applications for exemption from the minimal annual requirement will be considered on an individual basis.
